Exploitation of workers in the modern world.

Exploitation of human recourses is a direct product of post colonialism and political influences. Till date SPECPOL places immense emphasis on the wellbeing of disturbed laborers such as immigrants, refugees, asylum seekers and so on. Till date, the SPECPOL has legislated over a variety of cases, ranging from Israeli conflict management to granting autonomy to nations. It is responsible for furnishing a detailed and comprehensive document identifying the causes for exploitation, the proposals set forward to counter them and their repercussions. Modern exploitation includes child abuse, forced or bonded labor, slavery, immigrant and refugee exploitation, black market labor, organized crime, kidnapping and in most countries, prostitution.

Recently there have been numerous reports involving exploitation of factory workers in China, child labor in India, modern slavery in Qatar and racism to name a few. Another issue that has surfaced is that of organized crime or terrorism such as Boko Haram's abduction of female children who were sold into the sex industry and IS's recruitment of child soldiers.

SPECPOL must deliberate the conditions to be placed on member states, action to be taken against offenders, criteria for recommending the deployment of troops, refugees right to work in host countries and a host of other issues. The operations must also effectively integrate other aspects of the UN mission such as human rights and sustainable development.

Delegates will be expected to productively debate over the topic of reformation from all of its angles. Potential recommendations include expanding the legal mandate of peacekeepers, deploying operations that are

increasingly complex and expensive, designing sustainable transition strategies in regions with temporary geo-political stability, and reviewing the legal mechanisms undergirding the authorization, oversight, and financing of these actions. How does the nature of the labor affect the severity? Under what conditions should intervention or observations be deployed? What action should be taken against guilty nations and organized crime organizations? What Governmental policies should be passed regarding issues like refugees right to work and international cooperation? In fifty years, will the UN Peacekeeping Forces be around to serve the same purpose as they do today? The question of international peace, delegates,

lies in your hands.

OUR CONCERNS

Forced labor

Forced labor includes the migrant labor as well as low skilled labor whose rights are undermined by the employers for their 'business interest'.

Immigration and labor policies in some countries exclude immigrants from formal employment which makes them vulnerable. The victims suffer from very low wages, unwarranted or unexplained deductions, unpaid national tax and insurance by their employers.

The delegates will address work force regulation and enforcement of labor standards. The delegates will review it with other member states during the

meeting in addition to also assess security experts reviews made

in the previous committee forums.

Human trafficking

Human trafficking is a process of bringing someone into a situation of exploitation. Human trafficking is the trade in people, and does not necessarily involve the movement of the person from one place to another. Human trafficking is a crime against the person because of the violation of the victim's rights of movement through coercion and because of their commercial exploitation, for instance sexual exploitation. The cyber revolution has by far escalated it in that it is more difficult to find the numerous exploiters whose operations take place on line.

The committee will again approach to defend the rights of the victims. The delegates will therefore research on the subject and case studies in their own countries and come up with suggestions for the effective solutions. As a committee we will make a resolution following the review on the research. This will also include the criminalization of the exploiters and minimum sentences for them.

Other issues include but are not restricted to:

- Terrible work conditions in Qatar 2020 FIFA World Cup
- Abduction and prostitution of children in Nigeria
- Recruitment of child armies by IS in Iraq and Syria
- Exploitation of refugees in Turkey
- Immigrant abuse in UAE
- Child labor in India
- Inadequate work conditions in Chinese factories
- Violence against prostitutes in Europe
- Illegal immigration though Cyprus



- Slave trade into Europe
- Bonded labor in France
